Parishioner Question Time opened with the Chair welcoming those present.

A. All Hallows Hospital

Mr Howard Green, Chief Executive of All Hallows Healthcare Trust gave a talk about the proposed changes at All Hallows Hospital. It was followed by parishioners asking questions and putting forward their views.

B. Emmaus Road Signs (Doc. 1)

Rebecca Wass, Deputy Community Leader gave a talk on proposals for new signage for Emmaus. Further details point 9a.

C. Green Lane – Unsociable Behaviour

A resident spoke of the unsociable behaviour in Green Lane (noisy vehicles, possible drug dealing etc.). The Chair reported that Bob Edwards (NCC Highways) had advised the lane is a byway open to all traffic and belongs to Ditchingham Estates. Although DPC has no responsibility for the lane, they do for the parishioners. The police have been told of the issues and the Safer Neighbourhood Team would be patrolling the area.

This session closed at 8.25pm and nine parishioners remained.

proposed by Emmaus. Cllrs. decided to support standard black and white directional signs only (not advertising). They were concerned at the placement of a sign at Drapers Lane, site of an RTA in 2014.

The meeting was convened at 9.04pm to allow public participation

Rebecca Wass, Emmaus Deputy Community Leader stated the sign would be to direct visitors away from Drapers Lane, but sat-navs do send traffic that way. Emmaus would be happy with the highways standard black and white signs.

The meeting was reconvened at 9.06pm

Proposal: This Council supports the installation of four highways standard black and white directional signs for Emmaus, Norwich, using present posts at Chicken roundabout, Drapers Lane and 2 x Belsey Bridge to replace the existing signs. Wording: Emmaus Retail Outlet and Cafe (with a directional arrow).

Proposed KW, 2nd RK, carried.

Station Road Flooding –Anglian Water has advised the pumps in Yarmouth Road, Broome will be replaced in September 2015. The research into the capacity of these pumps will continue.

Fly Posting - A letter has been received by the Council re the removal of posters contrary to Council policy. A Councillor (not the Council) removed the posters. The Council has reached an understanding with the Councillor concerned and where posters comply with the policy, they should remain.

b) Local Development

Councillor Bernard gave a verbal report. Main points:

WiSpire - WiSpire is currently working with a number of churches across Norfolk to speed up the broadband network.

Solar Panels - The possibility of siting solar panels on the village hall (using S106) is being investigated to reduce the village hall's energy costs, any extra revenue will go to the Council.

Village Fete - DPC will have a stand at the village fete to allow parishioners to voice their ideas for the future uses of S106.

c) Maintenance and Environment (full report Doc. 3)

Councillor Kirkpatrick gave his report. Main points:

Allotments - Majority of plots are well used, the holders of untended plots will be asked to surrender them in September. The Committee is considering fencing.

Cemetery – well maintained.

The Dip – Well used, but dogs are banned but they are being taken on and allowed to foul the area. The goals are well used and have been moved to allow the ground to recover. Youths have been asked for ideas to improve the Dip and Play Area.

Thwaite Road Play Area – an email has been received re a hole in the hedge and children leaving through it. It has been investigated and the hole is not in the play area, but in a field adjacent to the play area.

Play Area Annual Report – climbing frame condemned and quotes are being sort to replace. RK agreed to convene a meeting of the Maintenance and Environment Committee in the near future to deal with the items needing

attention.

d) Play Equipment Inspections and Litter Picking – Council wished to thank Mr Paul Austin for all his through hard work.

Pony – now removed from green areas.

e) Finance & Resources

The Chair gave a verbal report. Main points:

Background:

Emmaus Norwich at Ditchingham was established in 2009 and began trading in 2011. A recent refurbishment has created an additional 16 companion rooms and the upgrading of the car park and associated drainage for our social enterprise.

The community and social enterprise are growing steadily. To support and maintain that growth we need to increase our footfall in the shop at Ditchingham. We have a targeted Marketing and PR strategy, however maximising opportunistic custom from traffic flow on the B1332 will significantly increase our trading and additionally improves the customer experience. Customers, both local and those from further afield frequently report difficulty and frustration in finding us.

As a federation Emmaus has been rebranding over the past 12 months. Emmaus UK have some funds to support the roll out of the rebranding to use on vehicles and on onsite and offsite signage, which we are keen to capitalise on. There is an opportunity to revisit roadside signage with a view to securing professionally sign written, safe, secure and acceptable signs.

The community now numbers 11, with two residential staff members. Those joining us are more often than not coming from the Waveney Valley. We are certainly servicing the local community, with collections and deliveries in Ditchingham numbering over 170 and many more of course shopping with us.

We see ourselves as an active part of the community, hosting, supporting and participating in local events. We plan to open a bistro on site in 2016 through which we hope to consolidate our offer to the local community as a potential hub for building and strengthening community and individual relationships.

Overleaf is a map noting proposed sign location, sign content, design and dimensions.

Considerations:

We have suggested locations at existing signage points as those sites are already maintained by the highways agency, give due consideration to sight lines, ensure sufficient distance from the junction for road users to read and react, and are not obscured by foliage or other street furniture.

We would like to site signs at three locations noted in yellow, black and red.

As the sites are pre-existing the impact of 'littering or cluttering' the roadside is minimised.

The appearance will be tidy and professional and following dialogue with South Norfolk District Council, Highways will be considerably under 1m² in size.

We will ensure fixings attach the signs securely to supports and do not damage the protective coating of any posts.

They will be secure enough to prevent rotation or slippage.

Alternatively we will produce free standing signs secured to the ground to adequately resist traffic and wind buffering.

We like the wording below but are open to suggestions, for example Charity Shop.

1.c Further application

There is one further application for consideration received 06/07/2015 in respect of BA/2015/0211/FUL re Douglas House, Falcon Lane, Ditchingham. This was received too late to be included on the web site and hence in this report. The Chair of the meeting will advise the Council's recommendation in respect of this application.

2. Highways signage (EMMAUS)

Please refer to discussion in public session and separate item on agenda. The Council are reminded that they acknowledged and considered that the existing signage on the B1332 (white traffic signs) in respect of Belsey Bridge Conference centre was excessive. See July 2014 minutes. NCC & SNC provided various policy & enforcement papers for consideration at that time which will be available from the Clerk to inform discussions.

3. Station Road Flooding

Since the last meeting there have been several more incidents of foul water escaping onto the highway and onto residents' properties. The most recent, at the time of writing, was 7th July. The Council, along with local politicians and local authority officials, is putting as much pressure as possible on Anglian Water to try to bring forward the upgrade to the pumps in Yarmouth Road, Broome.

There has been a complaint by a member of the public that their fly posting artefacts were removed by the Council contrary to Council policy. This is being investigated by the Council compliant with the Council's Complaints Policy. The Chair will report on this matter elsewhere on the Agenda.

Allotments:

Having visited the allotments the majority of plots are well cared for but there are a number, which, if they have not been worked at the time of renewal in September will be asked to surrender them. We have a waiting list.

Cemetery:

The cemetery continues to be well maintained.

The Dip:

The Dip is being well used although it is disappointing that dog owners are allowing their dogs to foul the area.

The council would ask anyone who can identify the owners to contact a councillor.

The goals have had considerable use and as a result the posts have been relocated to give the ground time to recover. Thanks to the councillors who undertook this work.

Some of the youths who use the skate park have been asked for any further ideas for improvement there and on the Thwaite road play area BMX track. We will be looking at their suggestions.

Thwaite Road Play Area:

This continues to be very well used and much appreciated by many young families.

There has been an issue about children leaving the play area through a hole in the fence.

The hole is not in the play area, it is in the field adjacent to the play area. The children have to climb over the fence to get into the field to exit onto Thwaite Road. The committee will be guided by councillors as to how high we make the fence and how far down the field we go.

We have had the annual inspection done on 'The Dip' and 'The Play Area'. I hope the majority of councillors have seen a copy. It is a significant document and would have used a number of trees to print one for everyone. There is a considerable amount of work to be done on maintenance. A large climbing frame was condemned and was put out of action immediately, thanks to the councillors who undertook this work.

The committee will go through the document and address the points and get quotes. To do all the work will incur considerable expenditure.

The BMX track that was cleared the week of our last meeting was very quickly inundated with growth again.

I have been unable to find a long term solution to this that won't be very expensive. At present we are keeping it strimmed, but it may need a rethink when the young people get back to us.
